Terms & Conditions

TERMS AND CONDITIONS

This agreement contains the terms and conditions by which reGeneration Pilgrimage for Possibility (rGPP) agrees to provide the travel program in consideration for a Participant's payment.

RESERVATIONS AND DEPOSITS

A deposit of \$400 per person and a signed reservation application form is required in order to secure a reservation for the tour. Written confirmation will be sent after the deposit check has been received. Deposits and all payments may be made by check for no additional fee. For each payment made by any method other than by check, rGPP will add an administrative surcharge of 4% of the total amount of that payment.

PRICING

The total price for the tour (i.e., the land-based portion of the trip) is \$2,435. This takes into account general program costs, meals for the majority of the trip (9 breakfasts, 5 lunches, and 8 dinners), hotel accommodations based on double occupancy, and taxes for the foregoing. Note that for 4 lunch periods and 2 dinner periods throughout the course of the trip, participants will be at choice for their meals and must cover their own food expenses. In keeping with the goals of the pilgrimage, program costs include \$300 in donations to the inspiring educational projects on the itinerary. In other words, participation in the program alone helps sponsor these important projects. Additional donations beyond the tour price are not required but are of course welcome.

FLIGHTS

Participants are responsible for their own airfare and flight reservations. However, round trip group rate tickets arranged between rGPP and U.S. Air may be possible at the cost of \$1,422 from Los Angeles or \$1,633 from Denver. These rates are limited in availability and subject to change. Participants are strongly encouraged to contact rGPP as soon as possible regarding group rate reservations. No guarantees are made regarding group travel. There is no advanced seat selection for tour departures; however we will try to meet individual requests upon availability. Three hours advance arrival to the airport is necessary to insure adequate time for check in.

SINGLE OCCUPANCY AND SHARING

The supplemental price for a single room is \$780 per participant, per tour. Singles who wish to share with another tour member should request this at the time of booking and will be booked as a "single-share-if-possible" basis. The single price is charged initially. If at departure we have another person to "share," the single supplement will be refunded within two weeks after the tour ends. "Shares" cannot be guaranteed.

FINAL PAYMENT

Final payment for this tour is due 70 days prior to departure. If a participant books air travel through rGPP, and fuel surcharges and/or taxes on flights increase, they are added to the participant's final bill. Pricing is subject to change until the trip is paid in full.

INDIVIDUAL CANCELLATIONS AND REFUNDS

All cancellations must be in writing to rGPP and must be signed by the person who made the original reservation. Cancellations are only effective from the day they are received by us. No refunds are issued for cancellations received after the date the tour departs. All cancellations will be subject to a \$150 per person processing fee to offset the costs of handling the reservation. The fee will be charged regardless of the reason for the cancellation. In addition to the \$150 cancellation fee, the following charges will apply based on when rGPP receives the cancellation with respect to the date of departure. All fees are per person.

Cancellation charges:

- 125-70 days prior to departure - 15% of tour cost
- 69-46 days prior to departure - 35% of tour cost
- 45-31 days prior to departure - 50% of tour cost
- 30-0 days prior to departure - 100% of tour cost

DOCUMENTS

All participants must have a valid passport with an expiration date at least six months past the date of departure. Participants will receive all flight tickets, if purchased through rGPP, and other necessary documentation from reGeneration Pilgrimage for Possibility at least two weeks prior to departure.

BAGGAGE

Transportation, transfer and gratuities for one (1) piece of checked luggage per person are included in the cost of airfare, if a participant's airfare is purchased through rGPP. Each person is permitted to take and be responsible for one (1) carry-on bag not to exceed 9"x14"x22". The maximum weight will be dictated by the air carriers for the flights. Anything the airlines charge for checked baggage will be added to your final payment. Any luggage in excess of (1) piece of checked bag will be subject to porterage fees in addition to airline charges.

PARTICIPATION AND SPECIAL NEEDS

The reGeneration Pilgrimage for Possibility is considered active and requires participants to be in good health. Step climbing and walking on cobblestone streets are common on many programs and wheelchair access on motor coaches is rare. Any disability or condition requiring special attention must be reported to rGPP at the time of booking. rGPP is unable to provide individual assistance in walking, dining, coaches and other transportation vehicles, or other personal needs. If such assistance is required, it is the responsibility of each participant to secure the accompaniment of an able companion and to secure rGPP's understanding and consent for any such or similar necessary arrangement for assistance. Participants must notify rGPP of any medical condition, including illnesses and allergies, which may affect the health of the participant or fellow travelers. rGPP maintains discretion over whether to accommodate the condition(s). rGPP does not assume any responsibility for the condition(s), except to whatever extent it specifies a promise to do so in a writing signed by an authorized rGPP agent. rGPP reserves the right to decline to accept or retain any tour passenger should such person's health or general deportment, in rGPP's good faith judgment, impede the operation of the tour to the detriment of the other tour passengers.

INSURANCE

Insurance is not included in the tour price. Travelers are strongly urged to purchase insurance for protection against loss, cancellation, medical conditions or other emergency. rGPP is not responsible for any medical conditions that may occur during or prior to the tour. Please note that we cannot accept responsibility for any losses or expenses, which you or any member of your party may incur as a result of failing to secure adequate coverage. Insurance applications will be provided for travelers.

TIPPING

Each participant is responsible for providing tips for guides and drivers. To maintain integrity and good will with these service providers, and considering the quantity of services used, rGPP must collect tips from the participants, which is estimated at a minimum of \$145 per participant. These minimum tips are mandatory and, like more discretionary tips, are not included in the initial price for the tour. Participants are encouraged to provide additional tips in the event of outstanding service. Upon request, rGPP will attempt to designate such additional tips for particular service providers of the participant's choice, although no guarantees are made.

SMOKING

Smoking is not permitted on motor coaches or during group meals. Other restrictions may be placed on smoking for the health and/or comfort of other travelers or for legal compliance.

PROGRAM CHANGES

Deviations to the planned itineraries shown in published sources may occur, even though rGPP will employ good faith reasonable efforts to

prevent such deviations. In case rGPP deems it necessary to substitute an activity, due to unforeseen circumstances, or out of concern for the comfort, convenience, or safety of the participants, rGPP will employ good faith reasonable efforts to provide an activity or activities that are as similar as practically possible to the original schedule. In addition, some activities may be omitted entirely, without substitution, due to circumstances reasonably beyond rGPP's control. There will be no refunds for any of the foregoing itinerary changes. In addition, rGPP reserves the right to substitute hotels as is reasonably necessary, and any such change will also not result in eligibility for refund.

CANCELLATION OF TOUR

rGPP reserves the right to cancel the tour if it does not secure payment in full from a minimum of 30 participants by 70 days prior to departure. rGPP will issue appropriate notifications and refunds of moneys it has not yet forwarded to third parties in case of cancellation for this or any reason. Note that rGPP will abstain from purchasing tickets or otherwise forwarding any funds provided it by participants unless and until the minimum number of participants (30) have fully paid. However, participants should also keep in mind that rGPP is not responsible for the acts of third parties, including airlines, or for circumstances reasonably beyond its control (see "RESPONSIBILITY FOR PASSENGER ACCOMMODATION" below for further important details). Thus, just as with individual travel overseas, rGPP strongly recommends that participants purchase travel insurance in case unforeseen events cause a cancellation or other event that results in losses or damages (see "INSURANCE").

RESOLUTIONS AND DISPUTES

In the event legal or equitable action is initiated concerning the reGeneration Pilgrimage for Possibility, the exclusive venue of such action will be solely in the state, county, and city of the principal place of business of reGeneration Pilgrimage for Possibility.

RESPONSIBILITY FOR PASSENGER ACCOMMODATION AND SERVICES:

reGeneration Pilgrimage for Possibility (rGPP) is responsible for making all arrangements for tour services offered in the itinerary. Airlines, hotels, land operators and other suppliers providing services as part of, or in connection with the tour, are independent contractors and not agents, employees or associates of rGPP. Acceptance and confirmation of your reservation is at the discretion of the airlines even after full payment has been made. rGPP assumes no responsibility or liability in connection with the service of an aircraft, motor coach, taxi, or other conveyance, which may be used in the performance of its duty to the passengers. All vouchers and other documents for services issued by the company are subject to the terms and conditions specified by the suppliers and to the laws of the country where services are supplied. If the tour services as indicated by the itinerary cannot be supplied or there are changes in the itinerary for reasons beyond the control of rGPP, we will arrange for provision of comparable services. rGPP reserves the right to make changes in the itinerary whenever rGPP deems it necessary for the comfort, convenience and safety of participants at any time. The participant agrees that, to the greatest extent allowable by law, rGPP shall not be liable for any changes in flight schedules, delays, weather conditions, damages, losses (including personal injuries, death and property losses) or expenses occasioned by acts or omissions of any third party, including but not limited to suppliers providing services and fellow travelers, or for any acts of war, insurrection, revolts, or other civil uprisings, military actions, strikes, or acts of God occurring in the country of origin, country of through passage, or country of destination.

CHANGES IN AGREEMENT:

No term or condition in this agreement may be modified, added, deleted, or waived other than by written agreement between the affected participant(s) and an authorized representative of rGPP.
